



SUPPLEMENTAL \ BID BULLETIN NO.1

This Supplemental/Bid Bulletin is issued to modify, amend or clarify items in the Bidding Documents for the project: Supply and Installation of Solar Aviation Lights For Taxiway F2 and H1. This shall form an integral part of the bidding documents for the above-mentioned project.

The following were the queries raised by Evercon Builders and Equipment Corp. and Global Empire during the Pre-Bid Conference held on June 19, 2018, as well as the corresponding remarks or instructions made by the Bids and Awards Committee (BAC) and Office of Prime Responsibility (OPR):

1.	Clarification from Shirley Lagura of Evercon Builders and Equipment Corp.: With regard to the Philippine Contractors Accreditation Board (PCAB) license, may we know if we are required to submit the PCAB license for this project?	No.
2.	Query from Shirley Lagura of Evercon Builders and Equipment Corp.: With regard to the Financial Component, may we know if we would need to submit the Applicable Price Schedule (from abroad or within the Philippines)?	Yes. Please refer to item 13.1 of the Bid Data Sheet (BDS), which provides, "Bidders are required to submit, duly accomplished and signed: a) Bid Form; b) Bill of Quantities; c) Applicable Price Schedule (from abroad or within the Philippines). Please follow the attached format. Failure to submit any of the above shall be a ground for disqualification."
3.	Query from Roeder D. Dela Rama of Global Empire.: With regard to the Bid Document that is posted in the CIAC website for this project, may we know if this is the same Bid Document that is being sold by CIAC?	Yes.



Additional reminders and clarifications to all prospective proponents:

1. The bidding process involves non-discretionary pass/fail criteria, whereby, if a Bidder submits the required document, it shall be rated as "passed" for that particular requirement. In this regard, Bids that fail to include any requirement or are incomplete or patently insufficient shall be considered or rated as "failed".
2. The original and copies of the bids shall be typed or written in indelible ink and shall be signed each pages by the bidder or its duly authorized representative/s.
3. The deadline for the Submission of Bids is on **July 2, 2018 (Monday)**, no later than **3:00 PM** Philippine Standard Time (PST) at the Records Management Office (RMO) CIAC Corporate Office Building, Clark Civil Aviation Complex, Clark Freeport Zone, Pampanga. Late bids shall not be accepted.
4. The Opening of Bids shall be conducted on the **same day at 3:15 PM**, CIAC Board Room, Corporate Office Building, Clark Freeport Zone, Pampanga.
5. No additional documents shall be accepted by the BAC after the deadline for the Submission of Bids.
6. Prospective bidders are reminded that CIAC is VAT exempt. Thus, the bid offer or financial proposal shall be exclusive of VAT.

CIAC reserves the right to accept or reject any bids to annul the bidding process and to reject all bid proposals at any time prior to contract award, without thereby incurring any liability to the affected or bidders.
