

## CONTRACT AGREEMENT FOR THE OUTSOURCING OF SERVICES

THIS AGREEMENT, made this 28th day of December 2018 between **CLARK INTERNATIONAL AIRPORT CORPORATION** of Corporate Office Building, Civil Aviation Complex, Clark Freeport Zone, Philippines (hereinafter called the "**Entity**") of the one part and **LBP SERVICE CORPORATION**, of 21/F Petron Mega Plaza Bldg., 358 Sen. Gil Puyat Ave., Makati City (hereinafter called the "**Service Provider**") of the other part:

WHEREAS, the Entity invited Bids for execution and completion of services consisting of: **OUTSOURCING OF SERVICES** and has accepted a Bid by the Service Provider in the sum of **EIGHTEEN MILLION ONE HUNDRED NINETY EIGHT THOUSAND THIRTY SEVEN PESOS AND 00/100 (PHP18,198,037.00)** (hereinafter called the "**Contract Price**").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - (a) General and Special Conditions of the Contract ;
  - (b) Technical Specifications;
  - (c) Invitation to Bid;
  - (d) Bidding Documents (**ANNEX A**);
  - (e) Supplemental Bid Bulletin;
  - (f) Bid form including all the documents/statements contained in the winning bidder's bidding envelopes (**ANNEX B**);
  - (g) Eligibility requirements, documents and/or statements (**ANNEX C**);
  - (h) Performance Bond;
  - (i) Net Financial Contracting Capacity (NFCC);
  - (j) Notice of Award of Contract and winning bidder's "Conforme" thereto;
  - (k) Service Agreement as required by DOLE Department Order (DO) 18-A or DO 174.
3. In consideration of the payments to be made by the Entity to the Service Provider as hereinafter mentioned, the Service Provider hereby covenants with the Entity to provide for the execution and completion of services and to remedy defects therein in conformity in all respects with the provisions of the Contract.

4. The Entity hereby covenants to pay the Service Provider in consideration of the provision of services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.

IN WITNESS, whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.


